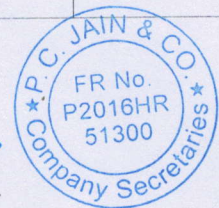

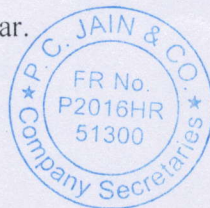

No approval was required to be taken from the Central Government, Tribunal, Regional Director, Court or such other authorities under the various provisions of the Act. **However the company obtained approval from Registrar of Companies for extension of 2 (two) months till 30th November, 2019 for holding annual general meeting of the Company for the Year 2019 under section 96(1) of the Companies Act, 2013.**
15. The Company has not accepted, renewed and repaid any deposits during the period under review.
16. The Company has not borrowed any money from its directors, members, public financial institutions, banks and others during the year. The Company was not required to create/modify/satisfy any charge during the year.

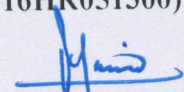
